### **RULES:**

1. A check for \$20 (nonrefundable and made payable to CWSLL) must be received before an applicant will receive a jersey.
2. Players will be divided into two teams based on number of participating players.
3. **Each player is responsible for furnishing her own equipment except game jersey.** I agree that should I borrow any equipment from a coach, fellow player or school, the league or anyone else, that this will be a mere accommodation resulting from failure to supply my own required equipment. Therefore, the party lending such equipment shall not be responsible for its safety or condition.
4. **Participants are responsible for supplying their own mouth guards and PROTECTIVE EYEWEAR. These shall be worn or players may not participate.** I acknowledge that lacrosse is a potentially dangerous sport. I agree to indemnify and hold harmless the league, its organizers, directors and officers; any sponsors, officials, supervisors, the owners of fields and of equipment used; other participants, and anyone providing me with transportation from any claim or liability, including cost of defense, arising out of my participation.
5. By signing this application, I hereby promise and represent that I have had a recent physical examination by a licensed physician, that there has been no material change in my physical condition since that examination, and that I have been found and am currently medically and physically fit to play lacrosse.
6. I assume all responsibility for my own transportation to and from games. The league will not be responsible for any transportation liability for any injury arising out of transportation supplied by others.
7. If the undersigned applicant is under the age of 18 years, a parent or legal guardian must sign this form.
8. **NOTE:** No alcoholic beverages will be consumed on team benches, at the playing field, or adjacent parking areas. Violation of this rule could bring suspension or expulsion from the CWSLL.
